I am directed to refer to the approval of the competent authority to release an amount of Rs.55,80,00,000/- (Rupees Fifty Five Crore Eighty Lakh Only) as 1st installment of Infrastructure Grants to 93 Colleges at the central: state share of 60:40 to be incurred to the State Government of West Bengal under Rashtriya Uchchatar Shiksha Abhiyan (RUSA). Under the initiative under reference, the Central Government shall provide assistance to the State Governments for various components, which are mentioned as per the guidelines under RUSA.

- In accordance with the instructions of the Department of Expenditure, Ministry of Finance, Government of India, vide D.O.No.32/PSO/FS/2015 Dated 28th October, 2015 for Category States, the funding pattern is revised West Bengal comes under the General Category States. 1st installment of Infrastructure Grants to 93 Colleges at the central: state share of 60:40 to be incurred to the State Government of West Bengal under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) amounts to Rs.55,80,00,000/- (Rupees Fifty Five Crore Eighty Lakh Only). Further installments of the allocation shall be released by the Ministry only after the State Government concerned releases its committed share towards non-recurring expenditure and recurring grants, besides submission of the Utilisation Certificate by the State in respect of the installment of the Central grant released.
- 3. The sanction is issued in exercise of the powers delegated to Ministries under DFPR, 1978, as amended from time to time. Above grants are being released in accordance with the pattern of Assistance approved by the Ministry of Finance, Government of India.
